Note 1: 120 semester credits are required for a Bachelor of Business Administration (BBA). Any required coursework not completed at Washtenaw Community College must be completed at Cleary or by transfer credit from another institution (as shown by official transcripts).

Note 2: Electives/General Education may be any Washtenaw Community College courses or transfer or may include credit for prior learning or proficiency exam credit. There is no fee for prior learning evaluation prior to the final term of the program.

Note 3: Scholarships are available for Washtenaw Community College transfer students. Other scholarships and financial aid are available to all Cleary students.

Note 4: Cleary core and major courses are completed on-ground or distance learning online. Thirty credits (thirty-seven for BBA degree completion programs) must be completed with Cleary University to fulfill residency requirements. The maximum number of credits that may be transferred to Cleary University is 90 semester (83 semester for BBA degree completion degrees) credits. Consult a Cleary academic advisor for class schedule information.
