



MEMORANDUM OF UNDERSTANDING

BETWEEN

ROWAN UNIVERSITY DIVISION OF GLOBAL LEARNING AND PARTNERSHIPS

AND

WASHTENAW COMMUNITY COLLEGE

A. Purpose

THIS MEMORANDUM OF UNDERSTANDING (this "MOU") permits union members who have successfully completed the courses for the Washtenaw Community College's ("WCC") Construction Supervision Associate in Science Degree, expedited access and entry to Rowan University's Bachelor of Arts in Construction Management online degree program, administered by the Rowan University Division of Global Learning & Partnerships and the Rowan University College of Engineering.

The education program developed by WCC provides comprehensive, industry-specific, technical education. Rowan University is a comprehensive public research university, offering undergraduate, graduate, doctoral, medical, certificate, and online programs.

Credit Assessment of WCC Program

WCC is entering into the MOU so that eligible members who have successfully completed their training program can continue their education with an online Construction Management degree. Most General Education and Construction Management courses required for degree completion will be offered by Rowan University.

WCC classes can be applied along with Apprenticeship Training and any nationally recognized college credits to the Rowan University Construction Management online program (Appendix A). Rowan University's Bachelor of Arts Degree requires a total of 120 required credits.

The courses under the current agreement are the WCC Apprenticeship courses found in Appendix A. The 38 credits are accepted towards the Bachelor of Arts in Construction Management Degree that requires a total of 120 credits (Appendix A). Rowan University will recognize all national curriculum delivered by WCC that adhere to standards set by the Council on Occupational Education (COE).

B. Admission

This MOU will serve to support and encourage the matriculation of WCC students and graduates. Rowan University will designate a point-of-contact to serve as primary liaison. Rowan University will also offer informational conference calls and in-person information sessions for WCC audiences.

In addition to these credits, students may (consistent with University transfer credit policies) apply credit from previously completed post-secondary study toward the Rowan University undergraduate Construction





Management degree. Specifically, graduates may transfer and apply additional credit hours to the degree for a total of 84 advanced standing credits. Students must complete a minimum of 36 credit hours earned through Rowan University.

WCC students must meet the following requirements to be cligible for credit:

- 1. Complete a Rowan University Application.
- 2. Submit an official WCC transcript.
- 3. If applicable, submit official transcripts from any previously attended college/university.
- 4. Include two letters of recommendation.
- 5. Submit a copy of a valid union card for tuition deduction if applicable,

C. Enrollment

1. Two enrollment options will be available to WCC students:

- a. Part-time enrollment with credits less than 12 semester hours.
- b. Full-time enrollment with credits at or above 12 semester hours.

2. Current WCC Students

WCC students currently enrolled at Rowan University will be grandfathered into this agreement.

D. Partnership Support

Highlighting and informing students about the WCC/Rowan University partnership will include:

- 1. WCC development/inclusion of partnership information in educational materials.
- Rowan University development of WCC-specific informational insert(s) (paper & electronic).
- 3. Rowan University attendance/participation with WCC conferences/meetings as appropriate.
- Rowan University offered program conference calls and/or information sessions for WCC audiences.
- Rowan University will review transcripts and award successful college-level transfer course equivalents.
- 6. Tuition fees will be reduced to \$419 per credit hour regardless of in-state or out-of-state residency.

E. Partnership Terms and Agreement

- 1. WCC will send to Construction Supervision Associate in Science Degree graduates information about Rowan's B.A. in Construction Management online program.
 - WCC will inform graduates of upcoming Rowan University Global Information Sessions or equivalent outreach events.
 - b. Rowan University will not share or sell this information to any third party.





- c. WCC shall assure that it has the proper permissions to provide the above-noted information to Rowan University and Rowan University shall not be liable for any claims brought due to WCC's provision of unauthorized information to Rowan University.
- 2. WCC certifies its Curriculum accurately reflects the training (hours of study, evaluation, on-the-job training) currently offered. WCC will inform Rowan University of curriculum change(s) as it occurs and within two weeks of adoption. Any curricular change will be reviewed by Rowan University within one month with corresponding adjustments to credit assessments.
- 3. The term of this MOU is September 1, 2019 through September 1, 2022. Partnership review and refinement will be performed on a continuous as-needed basis under mutual agreement. Either party may withdraw from the partnership by providing a six-month written notice of intent to withdraw from the partnership. The MOU may be renewed on an annual basis thereafter upon mutual agreement of the parties.
- 4. Both WCC and Rowan University agree to appoint designated staff to administer the MOU. These persons are charged with coordinating the work of the partnership, facilitating review of the MOU, and working collaboratively to address any and all administrative and academic issues that arise during the partnership period.
- 5. WCC and Rowan University will obtain prior written permission from each other before using the name, symbol and/or marks of the other in any form of publicity in connection with this Agreement. This shall not include legally required disclosure by WCC or Rowan University that identifies the existence of this agreement.

F. Transfer Credits

Rowan University will accept free elective credits with a letter grade of "D-" or better from regionally accredited educational institutions & credit transferring entities such as ACB and National College Credit Recommendation Service (NCCRS). The acceptance of free elective credits is contingent upon the approval of the appropriate Rowan University academic department.

H. Additional Items of Consideration

- 1. Rowan University is an agency of the State of New Jersey, USA. Any agreement signed on behalf of the State of New Jersey by a State official shall be subject to all of the provisions of the New Jersey Tort Claims Act (N.J.S.A. 59:1-1 et seq.), the New Jersey Contractual Liability Act (N.J.S.A. 59:13-1 et seq.), and the availability of appropriations. The State of New Jersey does not carry public liability insurance, but the liability of the State and the obligation of the State to be responsible for tort claims against its employees is covered under the terms and provisions of the New Jersey Tort Claims Act.
- 2. Neither party shall assume any liabilities of or pertaining to the other.





- 3. The parties to this Agreement are independent contractors. It is not intended that an employment, joint venture, or partnership agreement be established by this Agreement.
- 4. Each party shall be responsible for its negligent acts or omissions and the negligent acts or omissions of its employees, officer, directors, or agents, to the extent permitted by law.
- 5. Rowan University in its programs and services adheres to the State's non-discrimination policy for Affirmative Action and Equal Employment Opportunity. In accordance with that policy, discrimination based upon race, creed, color, national origin, ancestry, age, sex, marital status, familial status, affectional or sexual orientation, atypical heredity cellular or blood trait, genetic information, liability for service in the Armed Forces of the United States, or disability, will not be tolerated.
 - a. Sexual harassment, which is a form of unlawful gender discrimination, likewise will not be tolerated. While in performance of this Agreement, WCC certifies that it does not discriminate on these grounds either.
- 6. Notices, requests, and other communications required pursuant to this Agreement shall be in writing and shall be sent by first-class mail or overnight service (e.g., Federal Express) to each party as follows:
